This action being mentioned this day WHEREUPON AND UPON HEARING  
Mr. Trevelyan for the Plaintiff and Mr. Lee Solicitor for the  
Defendant AND UPON READING the Affidavit of James Anthony  
Meagher sworn on the 7th day of June 1966 and filed herein  
AND by consent a jury having been dispensed with and a verdict  
found in favour of the Plaintiff for the sum of Nine thousand  
Dollars (\$9000.00) for damages and Five hundred Dollars (\$500.00)  
for costs IT IS ORDERED that judgment be entered accordingly  
AND that the sum of Nine thousand dollars (\$9000.00) be paid  
into Court by the Defendant herein AND that from such amount  
the Prothonotary do pay out the following amounts:

To NEVILLE GOODE MURPHY the Plaintiff's next friend the sum of  
Eight hundred and nineteen Dollars (\$819.00) representing  
Six hundred and eighty one Dollars Forty Cents (\$681.40) the  
amount paid by him on behalf of the Plaintiff for hospital,  
medical and other expenses and the sum of One hundred and thirt  
seven Dollars sixty Cents (\$137.60) additional medical fees  
undertaken to be paid by him on behalf of the Plaintiff; and  
To the Plaintiff's solicitors the sum of Two hundred and fifty  
Dollars (\$250.00) for additional costs as between solicitor  
and client payable by the Plaintiff and IT IS FURTHER ORDERED  
that the Prothonotary do remit the balance of such verdict,

namely Seven thousand nine hundred and thirty one Dollars  
(\$7931.00) to the Public Trustee pursuant to the Damages (Infants  
and Persons of Unsound Mind) Act 1929-1947, for investment on  
behalf of the said infant.
